In order to qualify the applicant must provide the Scholarship Committee with the following:

1. Copy of the member's current dues receipt as proof that the member is in good standing.
2. Documentation from an accredited two or four year University or College only, showing that the applicant is a full time undergraduate student in the fall of 2018. (First, second, third and fourth year students are eligible). For example, a schedule with credits listed or a letter from the school's registrar's office.

- **No certified letters** will be accepted at the Post Office Box.

Winners will be chosen by a lottery system at the Council Delegates Meeting in the Month of November. One scholarship will be awarded per Local Union. Only one application per student will be accepted. Participants who were awarded in the year 2017 are not eligible. Such individuals may reapply in the year 2019.

Students must be a dependent, of a full dues paying member, of an affiliated Local Union of District Council 9 as of June 30, 2018.
